CVMC Meeting Minutes February 7, 2007

President Gordon Martin called the meeting to order at 7:33 p.m. He asked if we had any visitors. We had 2. They were Paul Wright who has a 1970 Mach I and Clark Jett who has a 2007 GT Coupe.

We had 67 members in attendance. President Gordon called on Treasurer Ron Martin for the treasurer's report. Steve Coleman made the motion to accept the report and Carroll Lipscombe seconded. The motion was approved by the membership.

Gordon said we had some guests with us tonight. Betty Wiseman came up and introduced. Billy Nunnally and Valerie Sipes who work with her at Bill Talley Ford. They told us about a child - Ray Newsome who just turned 14 and is a middle schooler at Stonewall Jackson Middle School. Ray has Leukemia and is not doing well. He just recently returned to school. He has had his leg amputated due to his cancer. It has also now has gone to his lungs. He has a love for mustangs. Billy found this out and when he heard that Ray was returning to school on his birthday

recently, he arranged to have several mustangs at the school. He said Ray was so excited. The project that he and Valerie would like for us to do is a car show to benefit Ray. His family has said that he might not see his 15th birthday and they would love for us to do this for him. We told them that we would discuss this and try to come up with a solution. We tossed around the idea of making it a cruise in at a local restaurant or local business. This would probably occur in March since the child is in such bad health.

Gordon then told us that Motor Trend has asked us to be at The Richmond Convention Center March 9, 10, and 11th for the Automobile Show. They are allowing us 20 spaces. Gordon put up a sign up sheet.

George Brobrovsky told us about the spring show. He said the show is only two months away. Renee Bennett has started the advertising. If we know of anyone who would like to sponsor the show, let George know.

Gordon reported on the recent Board of Officers meeting. We had around 20 in attendance. The main thing we decided on was making our Fall show a two day show. The dates of the show this year will be the 22nd and 23rd of September. It will be at Virginia Center Commons. We have been allotted 230 spaces for the cars with a total of 249 to allow for car corral and vendors. We have the proof for the flyers. We have changed the total flyer from the past years. We have changed categories; we have 13 rules and regulations. The reason for the change to the two day show is to allow the judges time to judge without being run ragged. Last year the judges didn't finish judging until 3:30 and the trophies were handed out at 4:00. This year with the two day format, if the judging isn't finished on Saturday, it would be concluded on Sunday. If you take your car off the field on Saturday, it has to be back in its space on Sunday by 8:30 a.m. If you win a plague for your entry, you must be there to receive it. We are not mailing any plaques. Johnny McGrath and Larry Boyd are Chairman and CoChairman of the show. Any questions should be directed to them. If the people who have signed up to help don't call them, they will be calling you. Rick Nochta is the head judge. He will be having judging clinics. Larry Boyd, Rusty Wiseman and Dave Dickey have volunteered their homes for the clinics. Some of these will be held on Friday nights and some on the weekends. Rick said you don't have to have judging experience to judge. We will train and show you the ropes.

Gordon said our next Board of Director's meeting would be April 16th at Joe's Inn in Mechanicsville at 7:00 p.m.

We will have a trash pick up on March 24th. Dave Dickey gave a report on MCA. He read the new officers. He told us the benefits of joining MCA.

Gordon showed us the new club decals and he also had a shirt from the last show for sale. He said that George has decided to take over Merchandise so the shirts after tonight would be in George's car.

Joan McGrath won the 50/50 of \$22.50 and also won the second prize that was donated by Gordon which was a year's membership in the club.

Gordon adjourned the meeting at 8:58 p.m.

Ford Ships SVT Chief to South America

Ford Motor Co. is sending Hau Thai-Tang, director-advanced product creation and the Special Vehicle Team, to Brazil to serve as director-product development for Ford South America Operations.

Largely credited with the wildly successful redesigned '05 Mustang, Thai-Tang, 40, has enjoyed a quick climb up Ford's management ladder. Since joining the auto maker in 1988, he has served in various capacities, including Mustang vehicle engineering manager, where he led the development and launch of the '01 Mustang GT, V-6, Cobra and Bullitt GT models. Previously, he served as vehicle dynamics supervisor and vehicle engineering manager for the '00 Lincoln LS sedan.

Compared with the situation in North America, Thai-Tang will find business thriving for Ford in South America. In 2006, Ford's South America Automotive operations reported a full-year pre-tax profit of \$551 million, a \$152 million increase from 2005. Revenues last year improved to \$5.7 billion from \$4.4 billion in 2005.

Thai-Tang will work out of Ford's operations in Camarcari, Bahia, Brazil, and replace David Breedlove, who is retiring after more than 30 years with Ford.

Hermann Salenbauch will fill Thai-Tang's slot as director-advanced product creation and head of SVT.



KENSETH WINS AUTO CLUB 500 2/25/2007

Fontana, Calif. — Matt Kenseth took the checkered flag in the NASCAR Nextel Cup Series Auto Club 500 at California Speedway tonight, less than 24 hours after winning the Busch Series race Saturday night.

Kenseth, as well as team owner Jack Roush and interim crew chief Chip Bolin, spoke at a press conference immediately following the race.

JACK ROUSH - ROUSH FENWAY RACING "It speaks to the depths of the team, the effort they've made all winter, to be able to have two cars, a Busch car and a Cup car, that was able to perform so good here. It's a pleasure to have a chance to win here, which is the second race for our new association with Fenway Sports Group. The first call I got last night was from [team co-owner] John Henry; the first call I got this morning, I actually wasn't up when he called this morning, and he had a family thing to do, but we'll dedicate my part of this victory to John.

"He is the owner of record for the 17 car moving forward. The pit crew did an awesome job on pit road. I don't think we would've been able to have the result we had had they had more trouble than they had. The cars, Matt and I were just talking about, they have the characteristic to be aero-tight here, so you get a car that runs really as good as it should and does what it needs to up front, and it won't be right behind three or four other cars. The 48 [Jimmie Johnson] car had a bad stop, it looked like, and they got stuck back there. But the pit crew did a great job. Matt was in tune with Chris Andrews, our engineering

manager, and Chip Bolin [interim crew chief], who's stepping in and doing a heck of a job.

"We've had conversations with Chip different times over the years about what he might like to do, and he's always said he'd rather not have the responsibility to do what Robbie [Reiser, crew chief] had been doing, but he got thrust in to it and has done a really good job. I'm just glad to be here and a part of this myself."

MATT KENSETH - NO. 17 CARHARTT/DEWALT FORD FUSION "Really, the car was really good all day. Where we started, I was kind of pleasantly surprised, it was a little too tight but we were able to make a way forward those first couple of runs. So, I was really pretty pleased with it. We didn't have to make a lot of changes. When we were down to quarter-pound adjustments I knew we were pretty close.

"One time we'd fight a little too free and sometimes we'd fight being a little too tight, but we were always pretty close and it seemed like we were always able to maintain the top three or four. The pit thing, we got lucky and pitted it right in the beginning of the race to get us our track position and we were able to hold on to that, and a couple of times the cautions fell right for us, for sure, and got us back up front. Overall, it was a great day. Robbie did a great job with this car, he worked on it all week while we were in Daytona [International Speedway], and got the team prepared to come out here. Chip did a wonderful iob all weekend, and all last weekend, as well. Just lucky to be driving this stuff, and it was a great day."

RIGHT BEFORE THE RED FLAG, KEVIN HARVICK WAS CHARGING PRETTY HARD. HOW CONCERNED WERE YOU? WHAT WOULD'VE HAPPENED HAD IT STAYED GREEN TO THE FINISH? "I was concerned. Our car was real good on a short run and the first three or four laps I was able to put a pretty huge distance up there, after that he certainly was cutting out of it every lap, was a little quicker every lap, and with seven or eight laps to go, I don't know, getting there is one thing, passing's another, but he certainly was faster at the time. He was certainly going to get there and make it hard. I don't know if we could've held him off or not. I'm glad we didn't have to find out. I started sliding the tires and I was using the tires up pretty hard, and the caution really helped us, was able to get the tires cooled off a little bit sitting there. They came back and felt almost as good as new ones for the last four laps."

ROUSH, CONTINUED ON BOUNCING BACK AFTER LOSING POINTS BEFORE THE SEASON. "We've made a decision to appeal the points thing. Certainly, we have no quarrel with NASCAR's prerogative to do what they'd like as far as deciding what's right and wrong, but the idea of taking points before we had any is unprecedented, and of course we're going to talk about that. We think that that's excessive.

"I've not been successful with appeals before, and I'll be surprised if I get relief, but I think it's justified and I expect really to have to lumber on.

"But Matt and the guvs have done what they can to start to put a dent in that. It takes a while to make up 50 points. With a few points a position, I don't expect to recover from that before we get to Bristol with the Car of Tomorrow. But hopefully we'll be back on track by then. To be able to come out here to the California track, which is one of our favorites, with the way you're able to race side by side—and really, somebody runs into somebody on the California Speedway, they're not doing what they need to be doing because it's a big, wide race track with a lot of grooves that work really well. It's been good to come back here.

"To answer your specific question, we'll do what we can with our appeal and just lumber on. We decided a long time ago we'd subjugate ourselves to NASCAR's policies and their determinations and we're just stuck with what we've got."

CHIP BOLIN - INTERIM CREW CHIEF, NO.17 CARHARTT/DEWALT FORD FUSION WHAT WERE YOU THINKING AT THE END? "We were hoping Kevin wasn't going to pass us, is what we were thinking. The guys did a really good job all day. Everybody keeps asking me all the calls I made and the things that were going on: I think Robbie deserves a lot of credit, in that he's the one that put this whole group together and told them all what needs to be done and how to do it. including myself, and he's got a machine here that will run itself as long as we all do the jobs we're supposed to be doing.

"He should be very proud of what we've done, just based on what he's taught us and what we've accomplished—without him being here with us."

WERE THERE ANY SURPRISES FOR YOU, STEPPING IN AS CREW CHIEF FROM ENGINEER? "No, not really, because, like I said, Robbie's got it all laid out, and I just go about doing what I always do and then just kind of pick up the slack on the things that he does. The group's been together so long and runs so flawlessly that we're just following what we're supposed to be doing, and it pretty much builds."

KENSETH CONTINUED THIS IS THE SECOND STRAIGHT YEAR YOU'VE WON AT CALIFORNIA AFTER A DISAPPOINTMENT AT DAYTONA, WERE YOU LOOKING FORWARD TO COMING OUT HERE? "I was looking forward to coming here. This year, for some reason during this off-season, there's probably been, at least on my part, more uncertainty than any other offseason, just because at the end of the year we didn't exactly set the world on fire the last five or six weeks. We took our cars, we've done a lot of different stuff, Chip and the engineer in the engine department did some different stuff, Robbie's done some different stuff aero-wise—I just wasn't sure it was all necessarily going to be the right stuff or if it was going to be the stuff we were going to come right out of the box and run fast with or if it was going to take a couple of months to figure out.

"So, I was pleasantly surprised about our third time on the race track we're running pretty darn competitive with this car. I guess to answer the question, yeah, I was looking forward to coming out. I didn't really know what to expect. Obviously, I'm very happy today."

WERE THOSE LAST TWO RE-STARTS AS GOOD AS YOU COULD HOPE FOR? "I was happy with them. Gosh, these guys did a great job for me all year long last year, put me in position to win a few races, and we were able to win a few, but I sure lost a few right at the end, too. I was real concerned about spinning the tires.

"Doug Yates [engine builder] and Jack, since they put that engine thing together, and now we've got excess horsepower, especially in second gear with these hard tires, and it's very easy to spin them when they're used. I did spin the tires—usually when I spin the tires I'm not real smart, I hold the gas down and it just goes slower and spins them faster—and I was able to breathe it a little bit and I could feel them hook up again and I was able to launch a couple of car lengths away.

"So that was important.
Getting through the gears and getting through one and two very fast is always important with a short run at the end. I think if you get a little cushion there it helps you because as aero sensitive as they are behind somebody, if you've got somebody tucked up right behind you it hurts you because you've got all the air on the nose and no air on the spoiler. So I think it's important to get that little bit of a gap, so you can have as much clean air as possible."

HAVE YOU TALKED TO ROBBIE? "I have not talked to Robbie since the race got over. I'll call him on the way to the airport. I haven't talked to him since the race got over.

"It was kind of funny—I was on him last week because he said he wasn't going to watch the race, and he walked in with 17 to go and I told him he needed to be watching the race, which is probably the wrong thing, I probably don't need to tell him anything right now because he's not in a very good mood, but I told him I thought he should watch the race and maybe scan some other people and learn some stuff and watch it.

"He made sure to tell me yesterday that he was going to be home and watch the race today. So I think he was watching on that [DirecTV] Hot Pass thing today, so I think he was going to try to get that and watch what we were doing. He should be real proud of the team he's assembled, like Chip said, he's done a great job and they always function at a top level."

ROUSH, CONTINUED "One of the comments I wanted to make before I get away from the table here is I want to compliment Sunoco for this environmentally friendly lead-free fuel that caused us no problem. We went through testing, practice and qualifying and we looked at the valve seats and inspected the engines carefully. We didn't have an issue with valve seat recession or anything else that was a concern. From what I can see the people that had trouble, it didn't relate to the fuel. The fuel gave us good fuel mileage and it performed admirably. I'm real happy to go forward with the Sunoco lead-free fuel. I think they did a great job."

BOLIN, CONTINUED WHAT WAS THE DIFFERENCE ON THE LAST TWO PIT STOPS? "I think the next-to-last pit stop was under green, if I remember correctly. The second one was under caution. Under caution, our guys, their expertise and their skill level tends to shine under caution because everyone comes in under it, you don't factor in speed-in and speed-out, it's just whoever's got the fastest pit stop is going to shine, and the group of guys we've got are really good. That's why you usually get that much attention."

KENSETH, CONTINUED "I think our pit stops were good all day, but our last one was one of the faster ones and it got us in position. As much as being a great stop, we did come in second and I think the 48 had some troubles."

WHAT DID YOU LEARN FROM THE BUSCH RACE THAT YOU COULD APPLY TODAY? "That's probably an answer Chip can probably give for you. We went over the stuff this morning and we basically left the car the same it was in Happy Hour. But we did learn some stuff last night. Chris Andrews [Busch crew member] and Chip were in the Busch Series pit all night and looking at the tires and tire pressures, and seeing how the track changed. The cars were set up fairly similar. The cars are enough different now where vou can't run the same set-up in both cars. But we basically had some of the same ideas, I guess, in both cars."

WHAT EFFECT, IF ANY, DID THE WEATHER HAVE ON TODAY'S RACE? "If anything, it probably made the track more consistent, because it was pretty much cloud cover all day. We didn't have sun in and sun out, and that change, and it usually puts more grip in the track the cooler it is. The track really didn't change much. We were able to make very, very small changes all the time, and it would really change our car. We were making quarter-pound adjustments, which I was really kind of laughing to myself and I'm sure Chip was probably laughing at me, but you could really feel it make a difference because the tires were real consistent and the track was real consistent because the weather was cool and overcast all day and it never really changed."

March 2007 Car Hobbyist News From the Council By Fred Fann

The General Assembly session is over and you can go to the Virginia Association of Car Councils website at www.vaacc.org and click on legislation to check on all the automotive related bills. I wish to review the most important ones to car hobbyists.

First was the antique registration bill. When the bill was finally worked out in the House it went to the Senate transportation committee where transportation chair Senator Martin Williams added three amendments. One was added in committee and the other two were added on the Senate floor. I have called his office and talked with his staff and no one can tell me why he felt these changes were needed. He has not returned my emails. Senator Williams amended the bill to restrict pleasure driving to 250 miles of the owner's residence. This is what got us

into trouble after the law was changed in 1999. Some people thought that 250 miles meant they could register a iunker as an antique and drive it as long as they didn't go over 250 miles a day. The other amendments were to strike out the prohibition on commercial use and to change the penalty for violation of the antique registration law from a Class 3 to a Class 4 misdemeanor. This makes the penalty the same as a speeding ticket - less incentive to not violate the law. While the commercial use is back in there are still parts of the law that will prevent driving an antique to work and hauling cargo.

What will happen when this becomes law on July 1st? Current owners of registered antiques will get a notice from DMV. This will be a certification that you will have to fill out, sign, get notarized and send back to DMV. You will have to state that you understand the antique registration law and that your antique vehicle has the proper working safety equipment for its year of manufacture. There will be no fee for this. We are going to monitor DMV on this to make sure everything is done as the law states. If vou register an antique after July 1st you will fill out the certification when you apply for the antique registration. The fee will be \$50.

The kit car/replica bills have passed. Both the House and Senate versions are the same. You will now be able to register a car that you build that resembles a previously manufactured vehicle as a replica. While you will have to pay annual license fees and get the vehicle inspected it may have the safety and emissions equipment of the year of vehicle it resembles.

Photo red has passed. Despite a study done in Virginia that found accidents, damages and injuries went up at intersections with photo red the Assembly voted yes to the program. You may recall a couple of years ago the Assembly killed photo red. There are some safeguards to try and insure the program is about safety and not just increasing revenue. It is

unfortunate that the General Assembly went backwards on this.

Cell phone use for those less than 19 years of age will be against the law. The age for requiring the use of car seats was increased from 5 to 8.

I have already heard complaints about localities trying to violate the law and charge repeat sticker/registration fees for antiques and I have also heard about localities trying to charge personal property taxes on antiques. Under current law I believe both are illegal. Being against the law has not stopped some localities from doing these things.

In Henrico the county violated state law by issuing county stickers that were larger than the code allows. The county received so many complaints that the supervisors met and decided to stop violating the law by not requiring residents to use the stickers. This cost the county taxpayers at least \$265,000. No one seems to care that the county violated the law.

If you have followed the Richmond newspaper articles on real estate assessments then you have learned that some localities have violated state law by increasing the assessments by large amounts without taking the steps required by law, not providing the calculations and methodology for the assessments and not allowing public disclosure of appraisal cards.

In other words stickers and taxes for antique vehicles are not the only state laws ignored by county and city leadership. It is truly sad that they can violate state law with no penalty.
