



DEARBORN, Jan. 28, 2009 – A new study by the world's leading patent analyst, The Patent Board™, found that Ford Motor Company outperformed all other automakers in the quality and significance of its technology patents.

"Ford's patented technologies are closer to the cutting edge than its competitors," says Christine Wren, director of business development for The Patent Board, which tracks and analyzes patents across 17 industries globally.

Technological innovation is a core value at Ford as the company drives for leadership in quality, safety, fuel efficiency and in-car connectivity. For example, the 2010 Ford Fusion and Fusion Hybrid, which is America's most fuel efficient mid-size sedan, have 119 patents, a record for Ford.

Hybrid technology – The Fusion Hybrid's powertrain system combines the best attributes of the gasoline engine and electric battery-driven motors to deliver the optimal experience for the customer in terms of driving performance and fuel economy. The overall system upgrade allows the hybrid to operate up to 47 mph in pure electric mode, approximately twice as fast as some competitors. The city driving range on a single tank of gas is expected to be more than 700 miles.

SmartGauge™ with EcoGuide – This unique instrument cluster helps coach Fusion Hybrid drivers on how to optimize performance of their vehicle for maximum fuel efficiency. traffic while backing out by using radars to pick up moving objects within a 65-foot range from either side of the vehicle. Two warnings are given: an indicator lights up in the corresponding outside mirror and an audible alert is sounded. The feature works in conjunction with Ford's radarbased Blind Spot Information System. utilizing this system's two multiple beam radar modules, which are packaged in the rear quarter panels one per side. The radar identifies when a vehicle enters the defined blind spot zone and illuminates an indicator light on the corresponding sideview mirror providing a warning that a vehicle is approaching.

EasyFuel™ Capless Fuel-Filler System - This industry-exclusive feature eliminates the need to touch dirty gas caps and helps to reduce evaporative emissions that create smog. When fueling is completed and the fuel pump nozzle is removed, the system automatically seals shut. # SUNTRUST RACING LEADS FORD-POWERED MACHINES

1/25/2009

Daytona Beach, Fla. — Another 24 hours at Daytona is in the racing books, and after a long day and eventful night of racing, it was SunTrust and Wayne Taylor Racing that led the way for the seven Fordpowered machines entered into the famous endurance race.

"We are happy coming out of here in fourth place," said Wayne Taylor, team owner and driver of the No. 10 SunTrust Ford Riley. "We got good points and we know now we have a good package. We have run 24 Hours so we should be able to finish the 2:45 [races]; our sites are on the championship. That is what it is all about for us."

This was the first race with Ford power for Wayne Taylor Racing after making the switch from Pontiac last season.

"Coming out of last year, we really had an up and down year but we ended on a pretty high note, continued Taylor. "Coming to a 24 Hour with a car you have never actually run for 24 hours is a challenge. Add to that the change in engine manufacturer switching to Ford power and that was

another massive change so coming in there were a lot of unknowns.

"Last night about four or five hours in, John Maddox [Roush Yates] Manager of Cammer Engine Programs 1 told me that it was possible that none of the Ford engines might finish. We spent about an hour talking about it amongst everyone and realized it was negative energy. We decided there was no point in worrying about it because if it was going to happen it was going to happen. So we said lets go race. If you take that perspective then this fourth-place finish is great, but we come here to win. We knew we couldn't do anything about it so we just decided to fight and go race. Maybe we got lucky or maybe there wasn't any problem at all."

The rest of the Ford machines weren't as fortunate as the SunTrust No. 10 to complete the entire race with the other six Ford entries experiencing the same electrical issue, resulting in early exits from the race.

"Our preliminary indications are that a common component failure related to the electrical systems was the problem in six of the Ford powered cars during the race," said Pat DiMarco, Ford Racing vehicle dynamics and electronics supervisor. "The lone Ford-powered car to finish the race, the SunTrust Racing entry, was running the same part as the other Ford cars batch that failed during the race. We will continue to investigate this problem and work to correct the problem for the next race."

#### **QUOTES FROM THE GARAGE**

DAVID BROWN – TEAM MANAGER, KROHN RACING: "The information that we have received from our engine tuner is that we suffered the same failure in the No. 75 car as we suffered earlier in the No. 76 car, as well as, we believe now, the 60 and the 6 and the 61 car, which is a crank sensor trigger failure inside the engine. It requires the removal of the engine, stripping of the front of the engine, stripping the front of the spare engine, taking the old part out of that and put that in the engine of the car. By the time we've done that, we will be in exactly the same position that we are now if we don't run again. Therefore, there is no point in running. Very, very disappointing though it is, this is the end of our 24 Hours of Daytona."

ERIC VAN DE POELE – CO-DRIVER, NO. 75 KROHN RACING FORD LOLA: The car was perfect when I restarted for my stint. We changed the aero a little bit for the car. I was right behind the Ganassi car and I was going to pass it on the straight. It would have been the first time in two years. It would have been perfect. When I moved away to make the pass, the engine just shut off. I had just enough time to dive into the pits and to coast to the garage."

A.J. ALLMENDINGER – CO-DRIVER NO. 6 MICHAEL SHANK RACING FORD RILEY: "I hate it for the team because this is a great group and Mike Shank does a great job so this is really disappointing.

"We weren't even pushing and the car was just so easy to drive that all we were doing was keeping to plan and setting a pace. This team works so hard, and that's why I keep coming back. I hate this, but I want to come back and win that [Rolex] watch. I know this team is going to be strong again this year but unfortunately we wont be getting them the start to the season that we were looking to."

JAMES PEW - CO-DRIVER NO. 6
MICHAEL SHANK RACING FORD RILEY:
"This car is such a pleasure to drive—I
did my fastest lap ever here [at
Daytona] in just my fifth lap of
practice this weekend, so to not even
get to drive in the race is really a
disappointment.

"We were doing exactly what we needed to do, and I was really looking forward to taking the car over in the lead but unfortunately just didn't get the chance.

"We had a great run here last year and there was no reason to think that we couldn't have been strong again this weekend but we just didn't get the racing luck to fall our way. But we are looking forward to the rest of the season. It's been great to have Michael [Valiante] join us and the engineers have really made a lot of progress with this car."

MICHAEL SHANK – TEAM OWNER, MICHAEL SHANK RACING FORD RILEY ENTRIES: "This is a huge disappointment for us because we've never had any kind of problem like this before, and to have both team cars get knocked out while running so strong is just a punch in the gut.

"If we weren't going to win this race, we wanted at least to start off right in the championship with some good points so unfortunately that's not the way it played out tonight."

### Bill Price's 93 Saleen SC This Ain't No Game Show

It seems that at times, things are not within reach, the timing is bad, the money is not there, or we get there too late. When it comes to Saleens, as with Shelby's, many of us just can't take that final step over the

precipice to ownership. I looked at that car several times at John Bleakley Ford in 1993 and 1994, but I just couldn't afford it, said Bill Price. We know that tune quite well. Around here we seem to sing it all too often when presented with a piece of Mustang history such as this convertible. If only we had the money. Because he wanted a one-of car, Bill drooled over the Saleen until it sold in 1994.

It is one of only five 93 Saleen SC's, one of three convertibles, and the only SC that is yellow Period. End of sentence. Of course, there are many components that make this ride special, such as the eye-popping Bright Canary Yellow paint, rocking ground effects, and the black with yellow appointments interior. Other components that jump out at you are the Canary Yellow 17-inch rims mounting P225/45-17 tires up front and P245/40-17 tires out back. Yep, visually it is about as subtle as a Sammy Sosa home run.



More subdued because of the eye-searing paint are the Saleen disc brakes with special Saleen Calipers that peek through the holes on the wheels. Backing these up is the Saleen Racecraft suspension with special progressive-rate springs, Saleen struts and shocks, and Saleen urethane bushings. Saleen also added a three-point lower brace and a g-load brace to stiffen the chassis, as well as one in the engine bay to further that along. This leads us to believe that this car handles and, according to Bill, it does.

Of course, Steve and the folks at Saleen didn't stop there. They piled on the appointments to the engine to the point that we decided to list them rather than wax poetic on them (see the sidebar Saleen Power). With the kind of power the 302 is capable of, you need some stuff to get it to the ground. There is a Saleen-shifted fivespeed and 3.55 Auburn rear-end to get the juice to the monster meats out back.

Creature comforts are there, too. Leather wraps the Saleen-spec'd Recaro front seats and matching back seat as well. There also is a lightbar and Spyder kit to round out the styling. For ground-pounding sound, Saleen spec'd a Pioneer system and six-disc CD changer for the SC. In front of the driver is the 200-mph speedo gauge package that gives you the idea that it might be useful.

After the car sold new from the dealership, Bill sort of forgot about it. During that time, it traded hands again and finally came to rest at Parkway Ford in Adarville, Georgia, with a scant 2,800 miles on the odometer. Bill's friend Derrick immediately placed a call and told Bill the car was there. Uhoh.



The scraping began, and Bill managed to come up with enough cash to buy the SC. Finally, the price was right.

## February 2009 Car Hobbyist News From the Council

The two one-plate bills did not last even a week in the General Assembly. The Senate version SB 937 was withdrawal by its sponsor Senator Ken Cuccinelli on the second day of the Assembly. A few days later the House version HB 1731 sponsored by Delegate Mark Cole was killed in the Transportation Committee by a 19 to 1 vote. Several people spoke against the bill: Police and Sheriff departments mentioned tracking stolen cars, using the new "license plate readers" (I don't think any are in use in Virginia), Amber Alerts and opposition from AAA and VDOT for toll enforcement. I mentioned at a recent car club council meeting that the members of the General Assembly have made it apparent they are not willing to go with one plate even if it will save millions of dollars over the years. It would also save resources since we would be producing half the plates and stickers. New vehicles are designed without front plates so there would be some savings in gas mileage. Also police officers' time would be used for better things than ticketing vehicles without front plates. The one-plate bills are dead for this year and with all the opposition to them it appears they have no future in this state.

You may have gotten the alert on the "cash for clunkers" program

and the stimulus package in Congress. As of this writing there is no such program in the stimulus package. There has been pressure from some to include such a program to help stimulate the economy but many are doubtful about these programs. Despite what has been in newspapers and on the Internet there are only two states that have such programs. The other states – including Virginia – have either never had a program or repealed them. The programs have been failures and currently there is no federal funding for them.

There are two bills in Congress for a program in which people are paid up to \$4500 for vehicles that are not fuel efficient as determined by the bill sponsors. People with the inefficient vehicles could get vouchers of up to \$4500 to purchase 2004 or newer more efficient vehicles. Both bills are in committee, one in the Senate and one in the House. The majority of bills in committee never make it out. Last year a similar bill died when the session ended. One has to wonder where the government is finding all this money after billions spent in the bailout bill and billions more will be spent when Congress passes a stimulus bill.

Here's something interesting. Those of you who drive Hull Street Road Route 360 in the Winterpock area know all about the heavy traffic congestion. The building of a new Wal\*Mart and subdivisions in the area will just make the traffic heavier. In 2008 VDOT did a study of the area. The study found that because of the congestion the faster traveling vehicles were not going the 55 speed limit. VDOT has reduced the speed limit to 45 in one section and to 50 in another. This isn't really a solution to the problem of traffic congestion. Reducing the congestion would mean a savings in gasoline, lower air pollution, reduce road rage and less time wasted in traffic means more time spend on productivity. Instead VDOT simply reduced the speed limit and that will not help congestion. This reminds me of what legislators do to stop a specific

crime. They pass a law against it. And if people continue committing the specific crime the next time the legislators meet they up the penalty for the crime. Then the next time they meet the legislators up the penalty again. What we need are creative workable solutions for the problems we face and not the same old same old from government at all levels.
