Superspeedway Testing Key For 2013 NASCAR Fusion, New Models DEC. 21, 2012

- In preparation for the seasonopening Daytona 500 in February, NASCAR teams participated ina recent test session at Talladega Superspeedway.
- The Talladega test represented the first on-track appearance for Penske Racing with Ford Racing since it announced earlier this year it would be returning for the 2013 season.
- The 2013 NASCAR Fusion will make its highly-anticipated debut in competition during Daytona Speedweeks, which begins with the Daytona Shootout on Saturday, Feb. 16 and concludes with the Daytona 500 on Sunday, Feb. 24.

DEARBORN, Mich. -- It's only been a month since the 2012 NASCAR Sprint Cup Series season came to an end, but teams and fans alike are already looking forward to what lies ahead next year with the debut of cars like the all-new 2013 NASCAR Fusion. And while many will be taking a break to celebrate the upcoming holidays with family and friends, most race shops will continue humming as teams build and prepare the new models for competition. The primary focus at the moment is Daytona Speedweeks, which is only two months away, and getting ready for the season-opening Daytona Shootout and Daytona 500.

Besides having a new Fusion to run with in 2013, Ford Racing will also welcome Penske Racing back to the program. Car owner Roger Penske is coming off his first NASCAR Sprint Cup Series championship in 2012 as driver Brad Keselowski captured the crown in only his third full season. The Penske organization, which also includes drivers Joey Logano and Sam Hornish Jr., got their first on-track work with Fusion during a recent test at Talladega Superspeedway.

"Ford probably did the best job in terms of what NASCAR wanted," said Hornish, who handled driving duties at the test. "NASCAR gave them the opportunity to give their race car a little bit more of the look of the actual street car. If you basically slinked up your car and made it into a street race car, this is what it could look like. I think they did a really good job of that and bringing out the character of the car."

Vice President of Operations for Penske Racing, Mike Nelson, agreed and said, "We're excited about the Fusion and the way it looks. There's a lot of buzz about it in the garage and in the shop, so it's been good so far. It means a lot to the fans and it means a lot to us as well.

It's nice to be able to look at the street car and look at the race car and see the similarities between the two. They're identical and it's cool for everyone."

That individual brand identity among manufacturers was a key element toward instituting this newgeneration car, but questions about components like the cooling system was one of the main reasons for having the Talladega test.

"It's been a challenge to get all the correct features in the car within the design parameters and still having the car competitive," said Ford Racing aerodynamicist Bernie Marcus. "At the end of the day you can have the bestlooking car, but if it doesn't work on the track, that's not going to be good so we have to have both. We have to have the looks and the performance."

Finding the right balance that will allow the cars to remain competitive and put on a good show for the fans is NASCAR's ultimate goal while making it to victory lane and winning championships is the primary focus for Ford Racing officials and its teams.

"There's been cooperation to get to the end goal of making the cars look the same on the race track," said Pat DiMarco, Ford Racing NASCAR program manager. "We've done that over the past few months and now we're working towards our goal of winning the Daytona 500."

Ford Racing has won the Daytona 500 two straight seasons and three of the last four overall.

The next chance for teams to test their superspeedway cars will be Jan. 10-12 at Daytona International Speedway.

News from the Car Club Council

It's hard to predict what the General Assembly will do in the next session. However it is safe to say we will be hearing two "t" words quite often - tolls and taxes. Tolls will be considered for any new road development. This reflects the fact that the state doesn't have enough road money to make all the transportation updates our elected leadership and VDOT feel is needed. The governor is still pushing for a toll on I-95 near Jarrett, VDOT savs that 80% of the bridges on I-95 are over 40 years old and 72% of the pavement needs maintenance. A toll on I-95 could generate \$250 million dollars over six years. If there is a lot of traffic on a road you can expect proposals for tolls. There have been protests over the proposed toll on I-95. People recall how long it took to get the old tolls removed from I-95.

The governor has also signaled that he is open to an increase in the gasoline tax. Currently Virginia has a

state gas tax of 17.5 cents per gallon that has been in place since 1986. Every state that Virginia borders has a higher gasoline tax. State Senator John Watkins is proposing some changes to the tax that could raise it by 14 cents a gallon. His proposal would also lower the state income tax rate for the lower two tax brackets to help poor people with the increase in the gas tax. Watkins is in my opinion testing the waters on the tax proposal by holding a town hall meeting and getting a lot of press on the subject of upping the gas tax. A year ago who would have thought a republican governor and state senator would be considering a gasoline tax increase from 17.5 cents a gallon to 31.5 cents a gallon?

There are now four one license plate bills coming up for consideration in the 2013 session: SB 27, SB 304, SB 423 and SB 771. Three of the bills if passed would get rid of the front license plate. SB 423 would eliminate the front plate if an auto manufacturer does not install a front bracket as original equipment. This would mean cars like Corvettes and Mustangs as well as others that do not come from the factory with a front plate bracket installed would not have to run a front plate. This is the first time there have been four one plate bills in the Assembly. As of this writing there are no companion bills in the House. If a one plate bill becomes law there will be a onetime cost of \$13,000 for programing, then \$2.3 million saved per year. In the past \$2 million didn't seem like much money to legislators but things have changed. The savings would come from keeping the registration fee the same while supplying one plate and one set of decals. I have heard that DMV has discussed the implementation of a one plate law. For years one plate bills have been introduced into the General Assembly with none of them making it out of committee. The State Police and some members of the Assembly have been against the one plate bills easily getting them killed. It will be

interesting to see what happens this session.

Links to all legislation and General Assembly info as well as the Code of Virginia are available on the site. I suggest you look through all the proposed legislation – it will be an eye opener.
