Return of the Ford F-100?

Ford's latest concept truck is a monster called the Atlas, but its next production pickup could be quite a bit smaller.

PickupTrucks.com has spotted a fleet of pickups undergoing testing that could mark the return of the F-100 model name, which would slot under the F-150 in the company's lineup.

Although far from confirmed, the heavily camouflaged vehicles appear to be slightly smaller than the current F-150, with a narrower track and body. They also ride on five-lug wheels, instead of six like the F-150, indicating a lighter duty ride. Based on the shape of the exhaust pipes, it's also possible that they were powered by diesel engines.

Ford discontinued the Ranger small pickup last year, saying the improved fuel efficiency and close pricing of the much larger F-150 made it redundant, but rumors have persisted that it could re-enter the segment soon.

In a recent interview with Car and Driver, Ford's truck marketing manager, Doug Scott, confirmed that the company had determined that a market still existed for a very affordable pickup with great fuel economy and capabilities like a 1,000-pound payload and 3,000-pound tow rating, but that a business case for it had not been pinned down.

First introduced in 1948, the F-100 was supplanted by the heavier duty F-150 in 1975, and essentially replaced by the Ranger in 1983. Interestingly, Ford recently introduced an all-new Ranger for foreign markets, but it wasn't engineered with the U.S. in mind.

Maybe the new prototypes explain why.

Bayne Shows Patience While Earning Stripes In NNS

Trevor Bayne is a patient man. This isn't necessarily expected from a

guy who just turned 22 years old, one who looks like he just left the Junior-Senior Prom or just finished posing for his yearbook photo.

But Bayne is more grounded than many in NASCAR with much longer resumes.

Patience is a virtue that comes both from his strong religious foundation and from his experience in stock car racing.

It might be assumed that a driver who won the 2011 Daytona 500 in spectacular fashion would be much further down the NASCAR trail as the 2013 season begins. But Bayne hasn't come close to running a full Sprint Cup schedule; in fact, the 2014 season might be his first in that situation.

In the meantime: Patience.
This season, Bayne again will
run a part-time Sprint Cup schedule
with the legendary Wood Brothers
team, but he'll be on a full-time clock
on the other side of the garage fence,
racing a complete Nationwide Series
schedule with Roush Fenway Racing in
the No. 6 Fords that Ricky Stenhouse
Jr. drove to Nationwide championships
in 2011 and 2012.

Bayne ran only six Nationwide races last season while waiting for his ship to come in.

Patience.

"It's been hard to wait, but I can trust in God's timing for this because it's always worked out, not necessarily the way I wanted it to but the way He wanted it to," Bayne said. "Why would I want anything different? I'd love to be Cup racing full-time already. I would love to have a year under my belt. But I've known this [Nationwide] opportunity was coming. And that helped me last year.

"If I had not known this was coming, it would have been a little harder. But watching them and seeing the 6 team work together and knowing that the car was the one I would be getting in, that gave me some more fuel for my fire and helped me get through the off-season."

Bayne often answers the question concerning the relative sluggishness of his rise, particularly

considering he wears the "Daytona 500 champion" tag. It's a reasonable inquiry, although the economics and other realities of the sport also impact how drivers move through the hierarchy.

"Last year, if we could have run full-time, maybe we could have run for a [Nationwide] championship and had an opportunity to run Cup full time," Bayne said. "Every season you're not racing for a championship or racing full time, it sets you back another year. Everything slows down -- slower than I want it to be.

"Like I said, I would love to be already running Cup. But now, with this opportunity, I'm going to take advantage of it. We won't let it slip through our fingers. When it's time to go Cup racing, we can move on."

Bayne has reason for optimism. He inherited the Roush Fenway team that raced to two straight Nationwide championships with Stenhouse Jr., who graduated to the Sprint Cup Series this season.

"We're going for the championship," he said. "That's what our goal is and what our expectations are. When they've won two championships already, that's kind of our thought process going into the third season. I don't think there's any reason we can't. This is the best group of guys I could ask for."

On the Sprint Cup side, Bayne figures he has a shot at more success in another part-time role with the Wood Brothers.

"We can do better," Bayne said. "Everything is kind of reset with the new (Gen-6) cars. Nobody has experience with the new cars. When we go to Vegas, nobody will have any experience with these cars.

"I know the Wood Brothers put everything into it every time we go to the track. Every time we're there, they put the best of the best on the track. I know we always have the best team they can field."

News from the Car Club Council

The General Assembly is still meeting as I write this so keep in mind things could still change plus we do not know what the governor will do with the bills that have passed both houses.

HB 1990 – this is the bill that last year car hobbyists were against and then for after it was amended. This year the amended version was introduced which was again amended. Car hobbyists were for this bill because this is included in the bill: "Nothing in this section shall be applicable to motor vehicles that are stored on private property for the purpose of restoration or repair or for removing parts for the repair of another vehicle."

In other words what this bill does is take away the possibility of a locality charging a penalty for a vehicle that is stored on your property that will be restored or used in the restoration of another vehicle if this bill is signed by the governor into law. It has passed both houses. Last year the governor vetoed this bill but since then the political landscape has changed and we are hopeful he will sign it into law. The bill does provide for a way for a locality to charge a penalty of up to \$250 for a vehicle owner who registers a vehicle in another state to avoid personal property tax in Virginia.

HB 1907 – incorporates several texting while driving bills. It will make texting while driving a primary offense. The bill text summary is below. It awaits the governor's signature.

"Driving while texting; primary offense; increased penalties. Provides

that driving while texting is a traffic infraction punishable, for a first offense, by a fine of \$250 and, for a second or subsequent offense, by a fine of \$500. The current penalties are \$20 for a first offense and \$50 for a second or subsequent offense. The bill also increases the punishment of any person convicted of reckless driving to include a \$500 mandatory minimum fine if the person was texting at the time of the reckless driving offense. The bill also changes the offense from a secondary offense (one that can only be charged when the offender is stopped for another, separate offense) to a primary offense. The bill also increases the punishment of any person convicted of reckless driving to include a \$500 mandatory minimum fine if the person was texting at the time of the reckless driving offense."

HB 2313 – this was the governor's plan for transportation funding. It has been amended and changed. On the final day of the session an amended version hammered out in conference committee was passed.

Gone is the 17.5-cent-pergallon tax on gasoline replaced with a 3.5 percent wholesale tax paid by distributors and a 6 percent wholesale tax on diesel fuel. The bill also increases the 5 percent retail salesand-use tax paid on most purchases to 5.3 percent. There will be an annual fee of \$100 on alternative-fuel vehicles, including hybrids. The 3% sales tax you pay at DMV when you transfer a title into your name will increase to 4.3%.

"This is a historic day in Virginia," Governor McDonnell said in a statement. "We have worked together across party lines to find common ground and pass the first sustainable long-term transportation funding plan in 27 years. There is a 'Virginia way' of cooperation and problem solving, and we saw it work again today in Richmond. "Others have criticized the plan. It passed the Senate 25 to 15 with 17 Democrats and 8 Republicans voting yes. 12 Republicans and 3 Democrats voted no. The bill goes to

the governor who is expected to sign it into law.

On the federal side we are waiting for President Obama to nominate a person to head the EPA after Lisa P. Jackson resigned. The news media savs the current front runner is Gina McCarthy, the current head of the EPA's Office of Air and Radiation. In this position she wrote most of the power plant emissions regulations during the first Obama term. Some of those regulations were struck down by a federal court. Her selection would indicate that Obama is serious about climate change regulations. McCarthy worked as an environmental official in Mitt Romney's administration when he was governor of Massachusetts.

"Her nomination signals that the president really wants to deliver on his State of the Union objectives to take serious action on climate change," Daniel Fiorina, director of the Center for Environmental Policy at American University, states. "I wouldn't say this changes the dynamics of the Keystone decision significantly — there are other considerations that are paramount but she knows air and climate issues very well and she's a very strong environmentalist." He is speaking about the Keystone XL pipeline and the fact that Obama has blocked its construction.

McCarthy may have some trouble with Senate confirmation. "I want to know who will respond to my outstanding request of one year and nine months regarding the scientific methods used to base the EPA's regulatory agenda," Senator David Vitter of Louisiana has stated. "Assistant administrator McCarthy is directly responsible for these concerns, and the failure to respond is not a good sign.... The administration should be looking for someone who will end

the standard of ignoring congressional requests, undermining tranparency and relying on flawed science.

"We should know in the next couple of weeks who Obama selects for EPA head and what decisions the governor makes on the legislation passed by both houses of the General Assembly.
