## ***MCA REPORT***



Former MCA President Arley Whitesell passed away last month. Arley joined National Capital Region Mustang Club in the early 90's where we became fast friends and attended many MCA shows together. Arley was an Auditor for the General Accounting Office in Washington, D.C. In the early 2000's he became MCA Treasurer and later President. He made many changes to the Treasury was a great asset to MCA.

In April MCA emailed me two changes for the By Laws that were discussed in the May newsletter.

**Change #1** - The three Tiered Membership package was approved as follows:

- **Standard Membership** is \$50.00 per year. This is the original MCA membership, but with the added benefit that standard members

may access the digital Mustang Times in addition to receiving a hardcopy of the Mustang Times via mail. The price of a Standard Membership will be higher for members living outside the United States due to the added postage cost of mailing.

- **Digital Membership** will be \$35.00 per year and have all the benefits of the Standard Membership EXCEPT; they will not receive a hard copy of Mustang Times. Digital Members will access the Mustang Times Digital Edition via a website link. The price of a Digital Membership is the same for all members, regardless of where they live in the world.
- **Associate Membership** will be \$25.00 per year and is the lowest priced level of MCA membership. Associate members have access to MCA vendor benefits, including the Ford X-Plan and have access to the MCA website. Associate members may enter MCA National and Grand National Shows and events. Associate members will NOT have access to the digital or hardcopy issues of the Mustang Times and may NOT vote or hold MCA Regional or National Office. The price of an Associate Membership is the same for all members, regardless of where they live in the world.
- All MCA memberships will be able to participate in the Ford X-Plan. You can go to the website [www.mustang.org](http://www.mustang.org) to choose one of the above membership options to join MCA and can join for additional years for additional discounts.

**Change # 2** - Auditing books upon change of MCA Treasurer:  
In the By Laws, Section 4, Treasurer: the sentence "The information shall include a copy of an annual audited financial report provided to the National Club by a certified public accountant" is to be removed and replaced with "At any time there is a permanent change in the Treasurer's office holder, an audited financial

report dated back to the most recent report will be performed". This change required all clubs to approve the change. As of the writing of this report, the above has not been changed in the By Laws. The complete By Laws are available on the MCA website.

There was not enough time to discuss the above changes at our May business meeting because the proxy had to be in to Headquarters by 28 April. The changes were emailed to CVMC Board of Directors, they approved both changes and the proxy was emailed on 27 April.

Our fall show is listed in the May issue of Mustang Times, on MCA's event website and on the Virginia Car Club Council website.

The other 2016 MCA National shows and the MCA 40<sup>th</sup> Anniversary Celebration are listed in our newsletter. Registration for all these shows is through Mottos.

MCA's 40<sup>th</sup> Anniversary celebration is September 1 to 4 @ the Indianapolis Motor Speedway complex. I was talking with an MCA board member who said the host hotel [DOWNTOWN](#) JW Marriott has only a few rooms left as do the other listed hotels. This board member also let it slip that the National Mustang Museum will be built just a few miles from Charlotte Motor Speedway hopefully opening in the summer of 2017. The website listing all chartered National clubs and their officers has finally been updated. I will now be able to contact the current central Virginia clubs to see how many are going to the 40<sup>th</sup> celebration to see if they are interested in the MORE parking program. I'll let you know the results. If you are going to the 40<sup>th</sup>, please sign the clip board on the table.

exclusive 2015 GT350 North American  
Track Tour at Pocono Raceway. Note  
the date in that prior sentence in that  
they started it last year. Bad news is  
it was quickly sold out. Good news is  
that they continued it for 2016 at  
Pocono Raceway and three other  
tracks.

Any original owner of a 2012/2013 Boss 302 and Shelby GT500 are eligible for this FREE event. Being an owner of both years of Boss 302s, I was able to participate in the half-day event at Pocono Raceway on Thu, May 19<sup>th</sup>. I have never been to the track before so I was duly impressed at its size, configuration, lodging accommodations and overall setting. Simply beautiful.



Nearly 100 men (and one woman) were given the royal treatment by Ford Performance as they described the program, the cars and the future. The Mustang GT350 joins the Ford F150 Raptor, the Fiesta RS and the Ford GT as four of the expected 12 cars to be released by 2020.

For this event, Ford had four 2016 Mustang GT350s and four 2016 Mustang GT350Rs for us to drive. They provided us with a helmet and modified HANS device for neck restraints. We drove 5 laps on the infield track with an instructor. Then we switched places for two laps holding on to enjoy the amazing driving by the instructor.

It was definitely a lot of fun. My only criticism was that I wish it was an all-day event as the Boss 302 Track Attack that I enjoyed twice at Miller Motorsports Park in Salt Lake City, UT.

## ***JUNE 2016 CAR HOBBYIST NEWS FROM THE COUNCIL***

*If you read this column on a regular basis you know I harp about errors on titles and why you should be very careful when you get a title transferred at DMV and also careful when you buy a vehicle to make sure the VIN on the vehicle matches the VIN on the title. Recently I gave some info to a man whose vehicle was titled with the incorrect make. Yes, someone at DMV actually put the wrong make on a title. I know no one would want their Chevy titled as a Ford or vice versa. He was able to get his vehicle's correct make on the title. The vehicle was a very rare imported car that most people have never heard about. But still DMV did make an error by changing the car into a more popular make.*

*And just this week I gave out some information to a man who had the incorrect mileage on a motorcycle. When he transferred the title a year ago the bike had about 11,000 miles on it. Now that he wants to sell it he noticed that the mileage on the title is 111,000 and it says "actual" miles. After contacting DMV he was told to produce three pieces of evidence to prove the bike has fewer miles than the DMV error. This is just like going to court where you have to prove something even though from looking at the bike and the title there is an oblivious mileage error. Could you prove your vehicle's mileage with three pieces of evidence? One would be the mileage on the inspection sticker paperwork. If you have an antique or other vehicle that was not inspected then you wouldn't have that documentation. Another possible piece of evidence would be any paperwork from a shop that worked on the vehicle and wrote down the mileage. You would have to hope the shop not only wrote the correct mileage but that it didn't leave the mileage off. A possible third piece of evidence you might be able to use would be a photo of the odometer. If you have a computer controlled vehicle it can cause a lot of problems (plus it is illegal) if you disconnect things to make the odometer stop working. I would take the photo and say since it is against the law to disconnect the odometer I didn't disconnect it.*

*Keep in mind how difficult it would be to come up with three solid pieces of evidence to prove your vehicle's mileage (or anything else) when you go to DMV to get a title. Carefully check EVERYTHING including not just the VIN but everything on the title including your name, address, make and mileage. If an error is made it is much easier to correct immediately. The longer you wait the more difficult it will become to prove you are right and that DMV made an error that either prevents you from selling the vehicle or greatly reduces the price you will get.*

*In mid-May the EPA came up with three final rules that were proposed because of climate change. Yes, even though it is a theory and most people don't think anything is being done about climate change the reality is plenty of actions are being taken by your government on climate change. The EPA says that these three final rules together will curb emissions of methane, smog-forming volatile organic compounds (VOCs) and toxic air pollutants such as benzene from new, reconstructed and modified oil and gas sources, while providing greater certainty about Clean Air Act permitting requirements for the industry. Bottom line the rules were set into place to reduce the amount of methane and VOCs entering the atmosphere from the production of oil and natural gas.*

*These new rules will affect natural gas well sites, oil well sites, natural gas production gathering and boosting stations, gas processing plants and natural gas transmission compressor stations. And what does this have to do with us? Well the EPA (not the gas or oil companies) has stated it will cost millions of dollars per year to engineer the changes needed to reduce methane and VOCs. The EPA report also states that the amount of oil and natural gas produced will be lower due to these regulations. EPA estimates that the dollar cost of production of oil and natural gas will go up a fraction of a percent. Sure! And the EPA says that the benefit in dollars will be higher than the cost in dollars to implement these rules. Do you believe that? I can't recall any EPA regulation that actually reduced the cost of a product. It is just additional cost we pay because of climate change. And that seems to be the goal with climate change rules – increase the cost of energy.*

*You may have seen those click it or ticket signs or signs about seat belt enforcement on the highways recently. This is because on May 12<sup>th</sup>*

*the NHTSA, the U.S. Department of Transportation's National Highway Traffic Safety Administration, kicked off a new seat belt campaign because of an increase in traffic fatalities. The agency's data indicates that while seat belt usage is at an all-time high, people are still being killed because they do not buckle up. From the agency's website:*

*"The Click It or Ticket safety campaign continues to be an effective tool to help change the attitudes of many occupants who do not use their seat belts," said Illinois Association of Chiefs of Police, First Vice President Jim Kruger. "So let me remind everyone that police will be mobilizing day and night to crack down on anyone who violates the seat belt law. If you choose not to wear your seat belt, you will receive a ticket." Law enforcement agencies will be out in full force encouraging drivers and all passengers to wear their seat belts.*

*The NHTSA is also stepping up those air bag recalls that you have heard about. The problem is the airbag inflators' propensity to rupture. My wife got a notice on her 2013 Mustang: "In certain vehicles, the front driver side airbag inflator housing my rupture in a crash necessitating deployment of the driver side frontal airbag. An airbag inflator rupture could result in metal fragments striking the driver or other occupants resulting in serious injury or death."*

*Doesn't that sound nasty? Plus Ford has known about this since July 2015 and yet the replacement parts are not expected to be available until "the fourth quarter of this year". That translates into October, November or December 2016. It does surprise me that car companies would let this problem continue which could mean even more lawsuits. You'd think it would be a problem they would want to fix quickly. Below is from one of the many law firms looking for clients for class action lawsuits:*

*"If your vehicle was one of the millions recently impacted by the recall of Takata airbags, you were likely shocked to learn that you were—or still are—driving around with a very dangerous airbag that could seriously injure you or your passengers."*

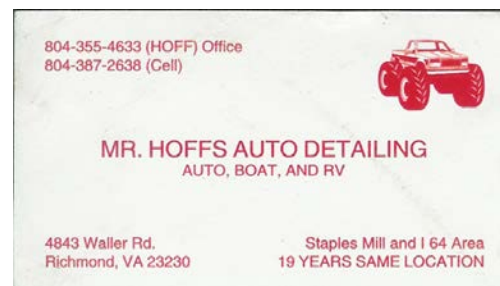
